LETTER FROM THE PRESIDENT



It is difficult to summarize in an annual report comprised of names and numbers the impact that your contributions make inside Great Smoky Mountains National Park. Even the photos included here cannot completely tell the story of one year in America's most visited national park, or capture the spirit of thousands of people who have invested in its preservation and protection.

The year 2017 brought the historic total solar eclipse to the Smokies, with thousands viewing the celestial occurrence from Cades Cove to Clingmans Dome. Donations to Friends of the Smokies supported educational and interpretive activities at locations throughout the Park, and these events streamed live to a wider audience through NASA's website.

Last year also saw the return of one of Friends of the Smokies' most popular events – the Cades Cove Loop Lope – after a seven-year hiatus. We thank Superintendent Cash and the staff of Great Smoky Mountains National Park for allowing us to bring back this rare opportunity for 500 runners to race along the Loop Road in Cades Cove early on a November Sunday and enjoy this remarkable place for a few hours without vehicle traffic on the road. We are also excited that it is becoming an annual event.

For the Park's fiscal year in 2017, which ran from October 1, 2016 through September 30, 2017, with your help Friends of the Smokies provided \$1,499,413 to fulfill a broad range of needs. Each year our Needs List from the Park is broken down into several major categories, including Resource Management and Science (things like controlling hemlock woolly adelgid), Resource Education (programs like Parks as Classrooms), Parkwide Volunteer Programs, Facilities Management (the Trails Forever work at Rainbow Falls Trails is one example), and Resource and Visitor Protection (funding for the Cades Cove Bicycle Patrol and other visitor safety initiatives).

You will find highlights from our 2017 Needs List throughout this report, and I hope you will be inspired to continue supporting Great Smoky Mountains National Park.

LETTER FROM SUPERINTENDENT CASSIUS CASH

Dear Friends,

Twenty-five years ago, people who love this park saw a need. They actively turned that great need into an opportunity that has now enabled thousands of people to help take care of this very special place. Their passion led to a movement that helped shape and define stewardship of Great Smoky Mountains National Park through the creation of Friends of the Smokies. As the Superintendent, I am honored that you have chosen to be a part of this movement to help us care for the remarkable stories, diversity, and experiences that these mountains hold for us and future generations.

Through your support as donors and members of Friends of the Smokies, you've helped us preserve historic structures, educate children, repair trails, and protect the forests, rivers, air, and wildlife that make

up these beautiful mountains. In 2017, your support also helped us host the largest special event in park history as people from across the world gathered in the park to view the Great American Total Solar Eclipse. Over 15,600 people attended eclipse events offered at our visitor centers and over 47,000 visitors entered the park to view the eclipse on August 21st. Another 26,000 people watched the live broadcast of the Clingmans Dome event in partnership with NASA, and another 6 million people watched the event online from across the world via the NASA 360 broadcast. The Smokies has long been a place where memories are made and, through your support, we were able to provide another once-in-a-lifetime experience for visitors.

In 2018, we look forward to several milestone events and celebrations. Notably, we are celebrating the 10th Anniversary of the Trails Forever partnership with Friends of the Smokies which has enabled us to complete multiple signature trail rehabilitation projects including renovation of the Forney Ridge Trail, Chimney Tops Trail, Alum Cave Trail, and Rainbow Falls Trail (which is slated for completion later this year). We look forward to expanding the reach of this program across the trail system in the Smokies as we embark upon the next ten years. We are also celebrating the 20th Anniversary of discovering life in the Smokies through the All Taxa Biodiversity Inventory. Through this program and our partnership with Discover Life in America, we've hosted over 1,000 researchers from across the world to help us record nearly 20,000 species of life in the park, including nearly 1,000 species new to science. We've used this opportunity to help create science learning opportunities for over 200,000 students, 6,500 teachers, and 1,000 volunteers who are helping us better understand and care for the rich biodiversity of the Smokies.

As we celebrate the 25th Anniversary of Friends of the Smokies, I invite you to continue on this journey with us in caring for this remarkable place. The need still exists, and we have hard work ahead of us. I continue to be inspired by the dedication of our supporters and advocates. It is indeed great to have Friends!

Last year saw the return of a very popular event – the Cades Cove Loop Lope – which only occurred once before in 2010. The Loop Lope offers both a 5K course as well as a 10 Mile race that traverses the entire Cades Cove Loop Road from start to finish. We are very grateful to Superintendent Cash and his entire management team for allowing us to host this event once again.

When registration opened on August 1st for the 2017 race, all 500 available spots were filled that day. The participants were also extremely thankful to have the chance to run the race on a beautiful Sunday morning in November.



“Cades Cove is a special place to my family because that was the only place we would vacation to as me and my brothers grew up.

My parents would attach our out-dated pop-up camper to my dad’s truck, we would cram ourselves, and our bikes into the truck and take off to the Smokies for as long as my dad could take off work. As soon as we got to The Cove, my parents would unload our bicycles and me and my brothers would take off through the camp ground finding other kids our age to play with for the few days or week that we were there. We would race around the loop, play in the creek, and go to the general store to get ice cream (usually free because the ladies in the store loved me and my brothers like we were their children). At the end of our vacation we would sadly pack our stuff and silently go back home, anticipating our next trip to Cades Cove.

This would happen 2-3 times a year if I remember correctly (as a kid it seemed like we almost lived there). Cades Cove feels as much a part of my family as does the house that me and my brothers grew up in.

I say all that to show how much The Cove means to us. And to have this race was something that brought back all those memories for me, and it was a great experience having almost my entire family there.

I can only pray that it becomes an annual event. If it does, you can guarantee the Culwell Family will be there every year!”

The board of directors and staff of Friends of the Smokies sincerely thank **Lindsay Young and the Aslan Foundation** of Knoxville for the \$2.3 million challenge grant which created the **Trails Forever Endowment** in 2008. The match was accomplished with the help of the friends and family members of **Tom Cronan and Margaret Stevenson** and many others who gave with the vision of revitalizing trails like Alum Cave, Forney Ridge, Chimney Tops, and Rainbow Falls.

Kathryn McNeil was a founding board member of Friends of the Smokies. Shortly before her passing, she challenged Friends of the Smokies to match a new \$600,000 gift, creating an endowment to fund a full-time, year round Parks as Classrooms Resource Education Ranger position. In 2000, she and Voit Gilmore donated their mountain home and 535 acre property to Great Smoky Mountains National Park, which today is known as the Appalachian Highlands Science Learning Center at Purchase Knob. It is where the endowment-funded ranger position serves.

Upon **Elaine Gibson's** passing, Great Smoky Mountains National Park's leadership team learned of her bequest to help take care of our park's greatest needs.



In calendar year 2017, Friends of the Smokies provided **\$1,448,230** to Great Smoky Mountains National Park to fund critical projects and programs. Here you will find some highlights of Park successes that could not have happened without your support!

COOK CABIN REHABILITATION

Walking into the backcountry of Little Cataloochee is also a trip back in time. There you'll find log cabins more than 100 years old that, while still charming, are showing their age. Contractor Sean Perry of Asheville, North Carolina found them, too, and realized that he and his company, The Hands of Sean Perry, possessed the skills and expertise to help the National Park Service repair and restore these aging structures.

Sean worked through Friends of the Smokies North Carolina Director Anna Zanetti and the Park's historic preservation staff to identify a priority project. They chose Cook Cabin, and Sean's crew donated \$6,000 in in-kind labor to replace the porch flooring. They spent a week in May 2017 working under the guidance of the park historic structure specialist. Friends of the Smokies contributed \$9,300 in materials to complete the work.

SOLAR ECLIPSE

On August 21, 2017 a total solar eclipse plunged parts of Great Smoky Mountains National Park into a midday twilight. The leadership team in our national park captured the opportunity to educate and engage thousands of park visitors and their families at Cades Cove, Oconaluftee Visitors Center, and Clingman's Dome. In order to present a world-class experience for this once-in-a-lifetime event, Friends of the Smokies provided \$21,000 to assist with bus transportation for participants to and from Clingman's Dome, to secure expert presenters like emcee Emily Calandrelli and NASA astronaut Soichi Noguchi, and to provide musical and theatrical entertainment.



TRAILS FOREVER REHABILITATION OF RAINBOW FALLS TRAIL

In 2017 the Trails Forever crew began tackling Phase I of the rehabilitation of the popular Rainbow Falls Trail. Leader Josh Shapiro provided the following series of before and after photos which highlight the problems hikers encountered along the Rainbow Falls Trail before the Trails Forever crew began their work, and demonstrate the quality craftsmanship and engineering employed by the team in the solutions to extensive erosion and trail surface issues. Their problem-solving skills make the hiking experience safer and more enjoyable for everyone who will trek to Rainbow Falls or Mount Le Conte along this route.

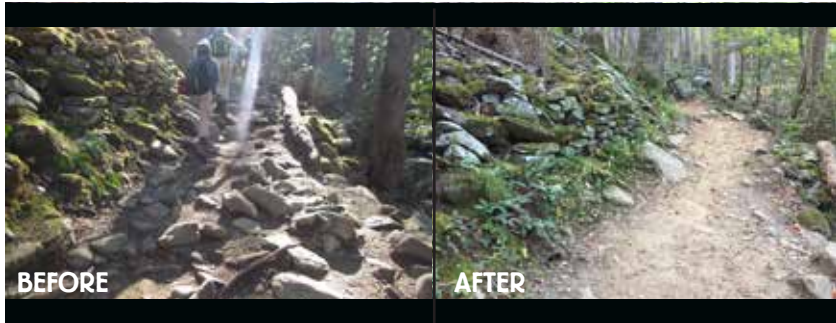


2017 Park Needs Fulfilled



BEFORE - Along the Rainbow Falls Trail, an example of trail trenching with exposed roots and no drainage, before the problems were addressed by the Trails Forever crew.

AFTER - The same section of trail, showing locust log steps constructed over the exposed roots, with an associated water bar to prevent water from running down the new steps and causing further erosion and trenching. This solution created safe footing while protecting the tree and its roots.



BEFORE - Rocks where a trail should be!

AFTER - Rocks removed, and trail tread sloped out to prevent water from pooling on the trail.

BEFORE - Trail trenched and eroded in the middle.

AFTER - To address the trail trenching and erosion, the crew removed the outside berm and added the soil to the center of the trail, which was next sloped and compacted to improve the trail tread. Drainage was incorporated above the area to prevent further erosion.

BEFORE - Another section of "trail" with erosion-exposed roots and rocks.

AFTER - The team built a system of rock steps, pavers, and water bars to create sustainable drainage in this area where none existed.



BEFORE - An heavily eroded section of Rainbow Falls Trail.

AFTER - The crew built a stone staircase and attached a water bar at the top to establish sustainable drainage and prevent future water damage to the trail.
